

Los Angeles County Office of Violence Prevention (OVP) Data Sources for Violence Prevention

The following document is a comprehensive overview of various data sources used by the LA County Office of Violence Prevention (OVP). The data sources included relates to incidents of self-inflicted and interpersonal violence, demographic and population data, school-related outcomes, crime-related incidents, and much more. Some data are available only through a request to the Office of Violence Prevention, but many other included data sources are available publicly online and are updated frequently. The Research and Evaluation Team (R&E) encourages our partners to use this document as a resource when seeking to develop or inform violence prevention initiatives or when conducting research activities.

We recognize that there may be several ways to determine which specific data is beneficial for different research questions or projects. The Research and Evaluation Team are available to provide assistance in identifying what data sources may be most useful and can provide support with accessing, interpreting, or utilizing this data. Mortality Data (Fatalities/Deaths)	Fatalities represent deaths due to illness or injury. This includes violent deaths from homicide, suicide, and legal intervention (officer-involved). Fatalities include homicides, suicides, and other incidents of premature death. They may also include deaths by legal intervention. Information for these deaths come from sources including the LA County Medical-Examiner Coroner, from death certificates, and from the National Violent Death Reporting System (NVDRS). Data available for fatalities among LA County residents include:
	 Method of death, including specific weapons used (e.g. shooting, stabbing, etc.) Demographics (gender, age group, or racial/ethnic group) Geographic data (residence location, incident location)
Emergency Department (ED) Visits	This data represents individual incidents in which LA County residents were treated in Emergency Departments throughout California specifically due to an incident of assault or a suicide attempt. These individuals involved in these incidents may have then returned home or may have later been admitted to inpatient settings. The data available represents each individual ED visit; it does not represent the number of individuals who have been treated in ED settings. Therefore, this data may represent multiple ED visits for a single person. Emergency Department data available for LA County residents include: Demographics (gender, age group, or racial/ethnic group) Method of injury, including specific weapons used (e.g. shooting, stabbing, etc.) Geographic data (residence location)



Hospitalizations (Inpatient)	Hospitalization represents individual incidents in which Los Angeles County residents were admitted into an inpatient hospital setting specifically due to an incident of assault or suicide attempt. The data available represents each individual hospitalization; it does not represent the
	number of individual people who have been treated in hospitalization settings. Therefore, this data may represent multiple hospitalizations for a single person.

Trauma Center Visits	Some hospitals are designated as Trauma Centers. These facilities have specialized staff and resources available to treat the most serious type of injuries. Trauma Center visits represents individual incidents in which LA County residents were treated at a designated trauma center specifically due to an incident assault or a suicide attempt. The data available represents each individual Trauma Center visit; it does not represent the number of individual people who have been treated in Trauma Centers. Therefore, this data may represent multiple Trauma Center visits for a single person. Hospitalization data available for LA County residents may include: Demographics (gender, age group, or racial/ethnic group) Method of injury/Weapon Used Geographic data (residence location, incident location)



MAPPING SHAPEFILES

Shapefiles are files used to visually represent data at the zip code, city, SPA, county, or state level in maps using mapping software.
